

Laurelton sits in that part of Queens where the city relaxes its posture a little. The streets are wider than people expect, the homes sit back from the curb, and the neighborhood carries itself with the careful calm of a place built for families who wanted space, light, and a sense of order. It is not a neighborhood that announces itself loudly. Laurelton reveals itself slowly, through tree-lined blocks, modest front yards, and a street pattern that still reflects an older dream of suburban living inside New York City.

That is what makes Laurelton interesting.
