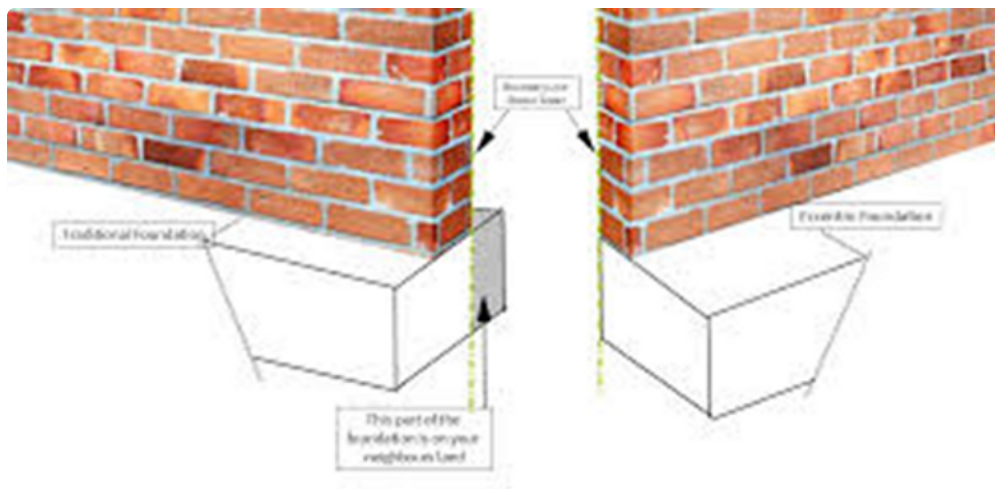

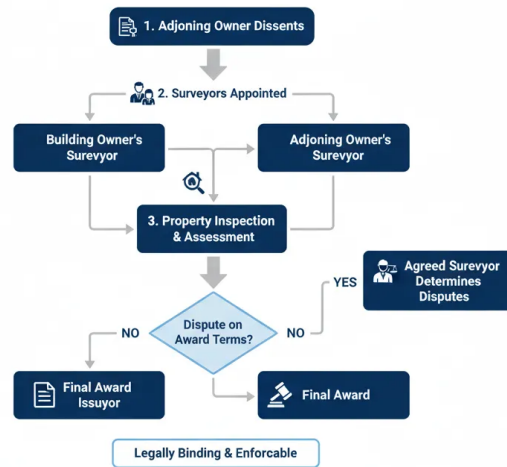
The Party Wall Etc Act 1996 Process Described

- Act 1996 is an Act of Parliament that gives a framework for avoiding and resolving conflicts regarding building work that impacts event wall surfaces, border wall surfaces, and adjoining frameworks.

Just How Much Does An Event Wall Surface Surveyor Charge?
