

When a family loses someone in a preventable wreck, the legal question is not the first thing on anyone's mind. It becomes one later, often when the bills arrive or an adjuster calls.

Georgia handles a death case differently than most people expect. Two separate claims generally [Atlanta accident lawyer](#) exist. One belongs to the surviving family for what Georgia calls the full value of the life of the person who died. The other belongs to the estate and covers the last medical expenses, the funeral, and any conscious pain before death.

Georgia law **atlanta personal injury attorney** sets an order for who may bring that first claim. A surviving spouse generally comes first, then children, then parents, and then the estate. Where there is a spouse and children, Georgia also sets a minimum share for the spouse.

Deadlines apply, and some of them are shorter than the general rule. A claim involving a city, a county or a state agency can require written notice long before a lawsuit is due. Evidence also disappears, especially when a company vehicle or a business is involved.
