A site has an owner, a general contractor, the electrical subcontractor, sometimes a utility, sometimes an equipment manufacturer, and sometimes a labor supplier. Each has different insurance and different incentives to point at the others.

Workers compensation pays medical bills and a portion of lost income when the injury is work related, and it bars a suit against your employer. It does not stop a claim against another company that caused the danger.

That third party claim is usually where the real recovery sits, because comp does not pay for pain, disfigurement, or the full economic loss of a career [truck accident lawyer](#) that ended early.

Working out who was responsible means getting the contracts, the safety plan and the daily logs, none of which an injured worker can obtain by asking.

Most personal injury lawyers in Georgia work on a contingency fee, which means the fee comes out of the recovery instead of out of pocket. There is no attorney fee if there is no recovery. Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer.
