The firm ensures that agreements are drafted with these enforceability requirements in mind: accurate financial disclosures are exchanged, [fairfax divorce lawyers](#) the signing occurs well in advance of the wedding date to avoid claims of pressure or duress, and the terms are explained clearly to both parties. Common subjects addressed in pre-nuptial agreements include the designation of pre-marital assets as separate property, protections for businesses or professional practices owned before the marriage, limitations on spousal support claims in the event of divorce, and provisions addressing the disposition of property in the event of death. For clients with significant wealth, children from prior relationships, or business ownership, these provisions can be particularly important.
