

If a bus crash injured you in Georgia, the deadline may be far shorter than you think.

An ordinary Georgia injury claim generally allows two years to file. Where a government entity owns the bus, written notice may be due in months rather than years, and it has to be in the right form and go to the right place.

Missing that notice can end an otherwise strong case before it starts.

Ownership determines almost everything here. Injuries on a public transit bus, a school bus, a private charter and a hotel shuttle each run on different rules. Ownership sets [check here](#) the notice requirement, the immunity questions and what insurance responds.

There is a second deadline nobody announces. Buses are heavily camerad, inside and out, and retention is often measured in days or weeks. Ask too late and there is nothing left to preserve.
