

What the Anion Gap Measures

The **anion gap** is a helpful way to interpret **serum chemistry** results and assess the difference between measured cations and measured anions in the body. It is most often used alongside an **electrolyte panel** to detect an **electrolyte imbalance** or an underlying **acid-base disorder**. While it is not a diagnosis by itself, it is a useful screening tool for clinical assessment and patient evaluation.

In basic terms, the anion gap reflects the gap between the positively charged and negatively charged components that are routinely measured in **serum electrolytes**. 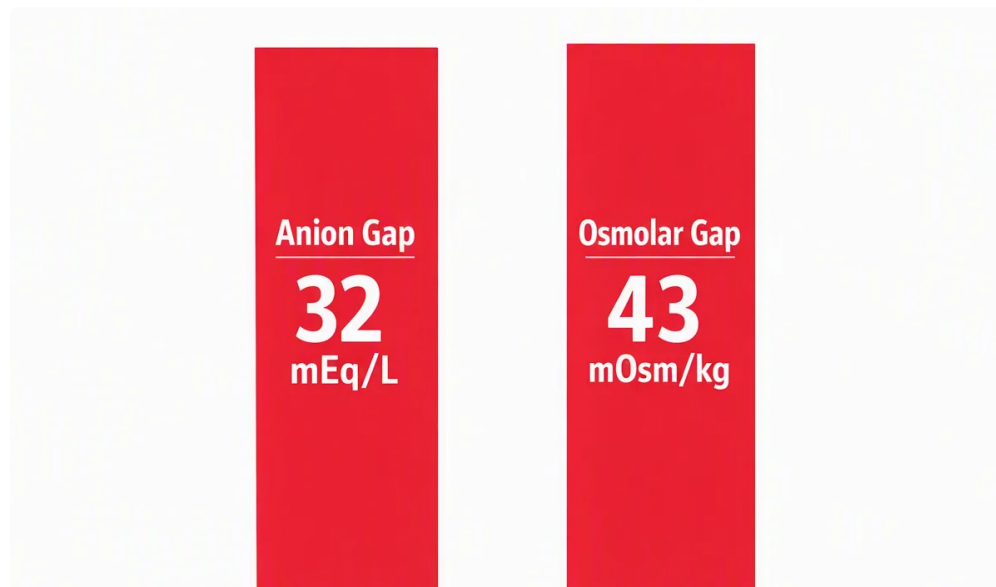
Anion gap = sodium – (chloride + bicarbonate)

to estimate the difference between measured ions and identify the presence of **unmeasured anions**.

The **normal anion gap** depends on the laboratory and the method used, so it is important to confirm the local **reference range**. A reported result should always be compared with the range provided by the lab rather than assumed to be normal or abnormal based on a single universal cutoff. Differences in analyzer technology, reporting conventions, and whether potassium is included can all influence the expected interval.

Causes of a Elevated Anion Gap

The result is a greater-than-expected calculated gap.

One common cause is **lactic acidosis**, in which lactate builds up during tissue hypoperfusion, severe illness, hypoxia, or other metabolic stress. Kidney failure is also a classic cause. As kidney function declines, the body becomes less able to clear acids efficiently, and retained solutes contribute to the widening gap. Other causes may exist, but these three are among the most clinically important because they are common and often urgent.

When the anion gap is elevated, interpretation should consider the context of the patient's symptoms, serum values, and blood gas findings.
