

When a rider is hurt and were hit around Atlanta, you are starting from behind.

There is a built in bias in motorcycle claims: that the rider was speeding, was lane splitting or weaving, or took a risk a car driver would not.

Sometimes that is accurate. More often a driver looked and did not register a single headlight.

The work is physical evidence, not story, since the story is doubted before it is told. The geometry of the turn carry more weight than either version of events.
