

If you or your child were bitten in the Atlanta area, the legal standard surprises most people.

In some places an owner is liable automatically. Georgia does not work that way. The question is normally whether the owner had reason to know the dog was vicious, or whether the dog was loose in violation of a local leash ordinance.

Proving prior knowledge is difficult. Owners rarely volunteer that a dog has snapped before, and witnesses on the same street tend to stay quiet.

Local ordinance **experienced truck accident lawyer** violations are usually easier to establish, so the early questions focus on whether the animal was restrained and whether a complaint was ever filed.

Records disappear quickly here. Prior complaints and recollections both fade, and the animal may be rehomed or euthanized before its history is ever documented.

How much does a personal injury lawyer cost in Atlanta?

Most personal injury lawyers in Georgia work on a contingency fee, which means the fee comes out of the recovery instead of out of pocket. There is no attorney fee if there is no recovery. Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer.
