

What the Anion Gap Measures

The **anion gap** is a calculated value used in **lab interpretation** to help assess **acid-base balance** and recognize patterns that may suggest a specific **acid-base disorder**. It is derived from common **electrolytes** in the **electrolyte panel**, especially **sodium**, **chloride**, and **bicarbonate**. $$\text{Anion gap} = \text{sodium} + \text{potassium} - (\text{chloride} + \text{bicarbonate})$$

Most modern laboratory systems and bedside references use the version without potassium because potassium is a smaller component of extracellular charge and adds little value in many routine settings. Still, understanding both forms can help when comparing historical reports or different clinical references.

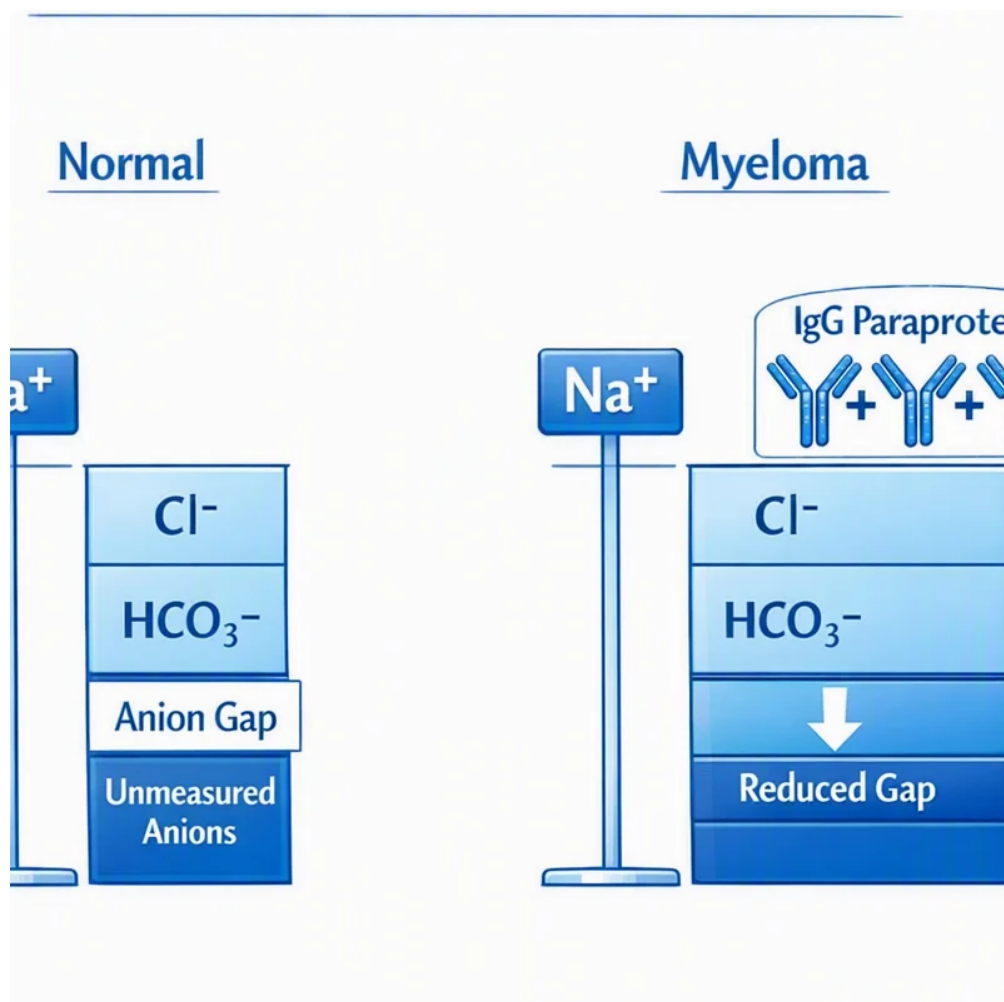
This measurement is also influenced by **albumin**, which is a major negatively charged protein in plasma.
