

If you ride and a driver did not see you around Atlanta, there is a prior you have to overcome.

Adjusters and jurors bring an assumption to these cases: that the rider was going too fast, [Check over here](#) was lane splitting or weaving, or took a risk a car driver would not.

Sometimes it fits. More often a driver looked and did not register a single headlight.

These cases get built on physical evidence rather than narrative, since the story is doubted before it is told. The geometry of the turn carry more weight than either version of events.

Injury severity cuts both ways. There is nothing around a rider, so the same impact produces far worse injuries. The defense response is often to argue the rider accepted **truck accident lawyer** that risk by riding at all.
