When the app is off, the driver is just a driver, and only the personal policy is in play. When the app is on and they are waiting for a ride request, a smaller layer of coverage generally applies. Once a ride is accepted or a passenger is aboard, a much larger commercial policy typically comes into play.

That timing is not a technicality. It can be the difference between a modest policy and a substantial one, and the app data that establishes it belongs to the rideshare company.

Whether you were riding, driving another car, walking or on a bike changes the analysis too. Each one [affordable car accident lawyer](#) can reach different policies.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer.
