

When a dog attack leaves someone hurt in Atlanta, the rules may not be what you assume.

Certain states impose liability regardless of the animal's history. Georgia is not one of them. The claim generally turns on whether the owner had reason to know the dog was vicious, or whether the dog was loose in violation of a local leash ordinance.

The knowledge route is hard to prove. People do not readily admit their dog has a history, and neighbors are often reluctant to get involved.

The ordinance route is frequently more provable, which is why the first questions are about where the dog was and whether anyone contacted animal control.

This evidence does not last. Animal control files and witness memory both degrade, and the animal may be rehomed or euthanized before its history is ever documented.
