

Losing someone in a preventable crash is not a legal problem first. It becomes one eventually, often when the bills arrive or an adjuster calls.

Georgia handles a death case differently than most people expect. There are generally two separate claims. One belongs to the surviving family for what Georgia calls the full value of the life of the person who died. The other belongs to the estate and covers the last medical expenses, the funeral, and any conscious pain before death.

Who may bring the first claim follows an order set by statute. It generally begins with a surviving spouse, then children, then parents, and then the estate. Where there is a spouse and children, Georgia also sets a minimum share for the spouse.

Deadlines apply, [truck accident lawyer](#) and some of them are shorter than the general rule. A claim against a government entity can require written [personal injury compensation lawyer](#) notice far sooner than the filing deadline. Evidence also disappears, particularly where a commercial vehicle or a business is involved.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer.
