

# Understanding the Anion Gap?

The **anion gap** is a calculated value that helps clinicians analyze **electrolytes** and judge **acid-base balance**. It is derived from standard serum chemistry measurements, particularly **sodium**, **chloride**, and bicarbonate-related values. 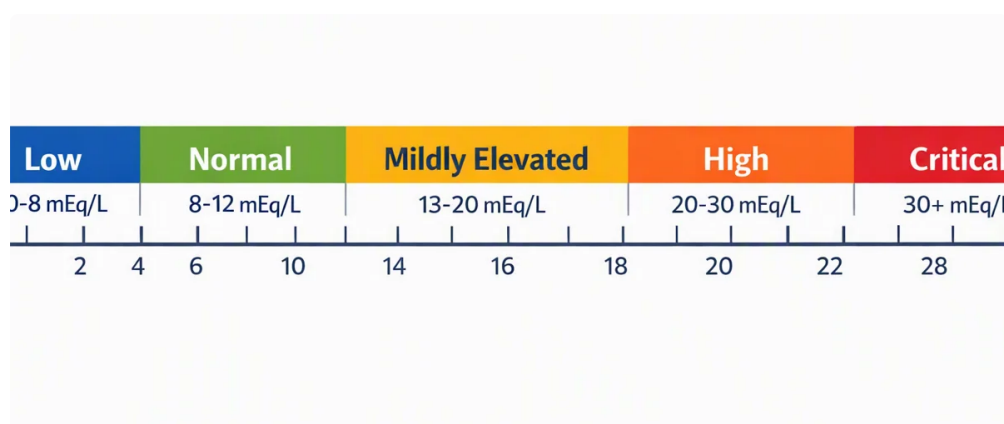
