Under Georgia law you generally have to show that the business knew or should have known, created it, or would have discovered it by inspecting the way a careful owner should.

Which is why moving early matters. Camera footage does not last long, and once it is gone there is no way to show how long the hazard sat there.

The report the store writes come from the business itself, which affects what [car crash lawyer](#) ends up in them. Sweep logs matter just as much, because a policy nobody followed is its own kind of evidence.

Most personal injury lawyers in Georgia work on a contingency fee, which means the fee comes out of the recovery instead of out of pocket. There is no attorney fee if there is no recovery.
