Workers compensation pays medical bills and a portion of lost income when the injury is work related, and it prevents you from suing the employer directly. It does not stop a claim against another company that caused the danger.

That third party claim is usually where the real recovery sits, because comp does not pay for pain, disfigurement, or the full economic loss of a career that ended early.

Establishing who controlled the hazard requires the site contracts and the safety documentation, none of which an injured worker can obtain by asking.
