

A truck wreck is not a car wreck. A loaded tractor trailer can weigh many times what your car weighs, and people tend to get hurt much worse.

The difference starts in the first hours. The trucking company often sends its own people to the scene the same day, before you are out of the hospital. They start protecting the company immediately.

Responsibility can reach past the driver. The carrier, a maintenance provider, a broker, or the company that loaded the cargo may each share responsibility. Each of those is its own question with its own evidence.

A commercial truck generates paperwork a passenger car never will: hours of service logs, engine and braking data, maintenance and inspection files, and the driver qualification file. Much of it can be overwritten or discarded on a normal schedule, so a preservation demand is typically sent right away.
