

When a dog attack leaves someone hurt in Atlanta, Georgia works differently than people expect.

In some places an owner is liable automatically. That is not the Georgia rule. [truck accident lawyer](#) The claim generally turns on whether the owner knew the animal was dangerous, or whether a leash law was being broken at the time.

Proving prior knowledge is difficult. People do not readily admit their dog has a history, and witnesses on the same street tend to stay quiet.

A leash law violation is often the clearer path, so the early questions focus on whether the animal was restrained and whether anyone contacted animal control.

Records disappear quickly here. Animal control files and witness memory both degrade, and the dog itself may be gone before anyone captures what it had done before.

Get medical care, report the wreck, and avoid giving a recorded statement to the trucking company's insurer before you talk to a lawyer.
