

If you ride and someone turned across your path in Georgia, there is a prior you have to overcome.

People arrive with a view already formed: that the rider was speeding, was lane splitting or weaving, or took a risk [local car accident lawyer](#) a car driver would not.

Occasionally that is true. Frequently the driver simply did not see the motorcycle and turned across it.
