



Structural damage rarely starts with a dramatic event. More often, it begins with something small, hidden, and easy to dismiss. A faint rustling in a wall. A soft spot near a window frame. Fine sawdust under baseboards. By the time those clues become obvious, pests may have already been feeding, tunneling, nesting, or contaminating critical parts of the building for months.

Rodents damage more than people expect

Rodents are often treated as a sanitation problem first and a structural problem second. In practice, both matter. Mice and rats can damage insulation, shred vapor barriers, contaminate stored materials, and widen small openings into larger access points. Their gnawing behavior can affect trim, drywall edges, and wiring pathways. In attics and basements, they can turn a small vulnerability into a broad repair project.

The structural risk with rodents is not always about one dramatic bite mark on one material. It is cumulative. Repeated nesting in insulation reduces performance. Constant movement through voids leaves droppings and urine that require remediation. Entry points around soffits, garage corners, and foundation gaps can grow over time, especially when weather and chewing work together.
