Start by Identifying the Type of Concrete Work You Need

Ask whether the contractor has worked on:

- Residential sidewalks
- Commercial sidewalks
- Concrete driveways
- Walkways and pathways
- Concrete steps and entrances
- Cracked or deteriorated slabs
- Uneven or settled concrete
- Concrete replacement projects

- Concrete surface restoration
- Projects involving drainage or surrounding landscaping issues

Relevant experience is particularly valuable when your property has multiple types of damage or when the visible concrete problem may be related to an underlying issue.

Check the Company's Reputation

Online reviews and customer feedback can provide useful insight into a contractor's reliability, communication, workmanship, and professionalism. However, reviews should be evaluated carefully rather than used as the only deciding factor.

Look for consistent patterns in customer feedback. Pay attention to comments about punctuality, communication, project quality, cleanup, professionalism, and whether the completed work matched expectations.

Ask for a Detailed Inspection

- Concrete depth and condition

Not every damaged concrete surface needs to be completely replaced. In some situations, localized repairs can restore functionality and appearance. In other cases, the damage may be extensive enough that replacement is more practical.

Concrete repair may be appropriate when:

- Damage is limited to a small area.
- The surrounding concrete remains structurally sound.
- Cracks can be properly treated.
- Surface deterioration is relatively localized.
- The underlying cause can be addressed.

Replacement may be considered when:

- The slab has extensive cracking.
- Large sections have settled or shifted.
- The concrete is severely deteriorated.
- The supporting base has significant problems.
- Repeated repairs have failed.

A trustworthy contractor should explain the advantages and limitations of each option instead of automatically recommending the most expensive solution.

Compare More Than the Price

Cost is naturally an important consideration, but the lowest estimate is not always the best value. Concrete work involves materials, preparation, labor, equipment, disposal, finishing, and other project requirements.

When comparing estimates, make sure you understand what each contractor is including. Two quotes may have significantly different prices because they propose different scopes of work.

A useful estimate should clearly describe:

- The areas being repaired or replaced
- Preparation and removal work
- Materials
- Labor
- Estimated project timeline
- Cleanup and disposal
- Any additional work that may be necessary

Comparing the scope of work alongside the price gives you a more realistic picture of the overall value.

Ask About Materials and Repair Methods
