Claims concerning celebration wall surfaces return to at the very least 1813 and a choice of the English Court of Common Pleas in *Matts v. Hawkins*, 5 Taunton 20 (1813). Ten years before the disagreement reached court, Hawkins demolished his building, leaving the event wall standing. In the future *Matts*, whose building still stood, started to extend the event wall surface up to sustain a flooring that *Matts* was including in his structure. When *Matts* started to restore it, Hawkins tore it down once again, and *Matts* sued Hawkins for trespass.
