

If you or your child were bitten <https://sethihc108.quillnesty.com/posts/fulton-county-18-wheeler-wrecks-what-the-carrier-does-first> in Georgia, the rules may not be what you assume.

Certain states impose liability regardless of the animal's history. That is not the Georgia rule. The question is normally whether the owner had reason to know the dog was vicious, or whether a leash law was being broken at the time.

The knowledge route is hard to prove. People do not readily admit their dog has a history, and neighbors are often reluctant to get involved.

A leash law violation is often the clearer path, which is why the first questions are about where the dog was and whether a complaint was ever filed.

Records disappear quickly here. Prior complaints and witness memory both degrade, and the dog itself may be gone before anyone captures what it had done before.

Most bite claims are paid by a homeowner or renter policy, which surprises people who assume they would be suing a neighbor personally.
