

An **anion gap calculator** is a practical tool for interpreting **acid-base balance** and narrowing the differential diagnosis of **metabolic acidosis**. It helps clinicians and learners turn a basic set of **electrolytes** into a more precise **diagnostic approach** by revealing whether unmeasured acids may be present. This gap is present because the body contains many **unmeasured anions** and cations that are not directly listed in routine lab results.

In acid-base physiology, the **buffer system** works to keep pH within a narrow range. When acids build up, their anions may not be immediately captured on standard labs. The anion gap gives indirect evidence of that accumulation. For this reason, the anion gap is key to interpreting **acid-base disorders**, particularly **metabolic acidosis**.

Most **anion gap calculation** methods rely on a basic formula based on measured **electrolytes**. The result is not a diagnosis by itself, but it can signal when additional evaluation is needed. How do you determine the anion gap?

The standard **anion gap formula** is:

Anion gap = sodium - (chloride + bicarbonate)

Some clinicians add **potassium**, but many do not because it contributes relatively little in most settings. A common alternative is:

Anion gap = (sodium + potassium) - (chloride + bicarbonate)

The calculator typically uses values on a **basic metabolic panel**, which is part of a routine **electrolyte panel**. Since the result is based on the exact numbers entered, even small shifts in **sodium**, **chloride**, or **bicarbonate** can alter the interpretation.

For instance, if sodium is 140, chloride is 102, and bicarbonate is 24, the anion gap is 14. That may fall within or slightly above the local **reference interval**, depending on the laboratory. What is a normal anion gap range?

The normal range is best understood as a **reference range**, not a universal rule. Albumin is among the most significant factors affecting the apparent normal range. 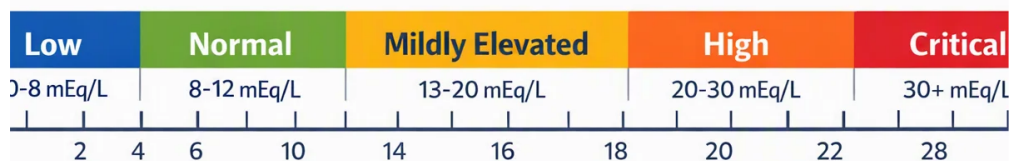

A **high anion gap metabolic acidosis** typically indicates that acids with unmeasured anions have built up. Common causes include **lactic acidosis**, **ketoacidosis**, **renal failure**, and **toxins**. What leads to a normal anion gap metabolic acidosis?

Normal anion gap metabolic acidosis is often called **chloride-rich acidosis** because chloride rises as bicarbonate falls, keeping the calculated gap near normal. A classic cause is **diarrhea**, where the body loses bicarbonate through the gastrointestinal tract.
